PORTER COMMISSION REPORT-POSSIBILITY OF SECURITY EXCHANGE REGULATIONS

On the orders of the day:

Hon. Alvin Hamilton (Qu'Appelle): My question is addressed to the Minister of Finance. It arises from a statement by the Secretary of State for External Affairs that mutually satisfactory arrangements concerning the S.E.C. would be made between the two countries, that is, between Canada and the United States. Does this imply that the federal government is now planning to set up some form of regulatory machinery in relation to a national security commission as recommended by the Porter commission?

Hon. Mitchell Sharp (Minister of Finance): The mutually satisfactory arrangements referred to in the communiqué were mutually satisfactory arrangements concerning the United States law. We took very strong exception to the extraterritoriality of that law, and we are hopeful that this aspect will be removed.

We did not bargain about our own regulations, but we did say that it is our intention to support the passage here and in the provinces of whatever legislative action we have to take in order to ensure that Canadian securities regulations are satisfactory for us.
