Mr. Macdonald (Rosedale): I understand arrangements have been made to try to get the estimates examined in committee in the near future, but I must say I have not been able to follow in detail the present status of all estimates in the committees. I will have to take a further look at that.

DISMISSAL OF COMMISSIONAIRES FOR LANGUAGE REASONS

On the orders of the day:

Mrs. Grace MacInnis (Vancouver-Kingsway): Mr. Speaker, I should like to direct a question to the Prime Minister.

In view of the consequences of the rule to the effect that members of the Canadian Corps of Commissionaires who are not bilingual are to be replaced in the three Ottawa museums on December 31, would the Prime Minister be ready to make an exception for veterans who will reach retirement age shortly?

Right Hon. P.-E. Trudeau (Prime Minister): Mr. Speaker, as everyone knows, national museums come under the jurisdiction of the Secretary of State, who would be happy to

Mr. Paul Yewchuk (Athabasca): I have a supplementary question for the Prime Minister. Is the replacement of the 10 to 15 civil service commissionaires by bilingual persons a sample of future policy which will affect the federal civil service?

Mr. Trudeau: Mr. Speaker, I merely wish to say that I can hardly be asked to state whether or not this is the policy because, as I said in my answer to the previous question, this matter comes under the jurisdiction of the Secretary of State. I am not familiar with the details of it; it is the Secretary of State who will have to report on it.

Mr. McGrath: Why not say "ditto"?

Mr. Jack McIntosh (Swift Current-Maple Creek): I have a supplementary question, Mr. Speaker. In the name of justice and of former commitments to these veterans, will the Prime Minister give consideration to rescinding or withdrawing that directive which emanated from the office of the Secretary of State?

Mr. Speaker: Order, please. It seems to me the hon. member is restating the question asked previously by the hon, member for Vancouver-Kingsway.

Mr. Yewchuk: I have a further supplementary question, Mr. Speaker. Will alternative employment be provided to these replaced commissionaires?

Mr. Trudeau: I would like to make it clear, as I did in my first answer, that this matter comes under the Secretary of State who is not in the house now. I am not familiar with the details of the matter, so there is no point in my trying to answer the question.

Mr. McIntosh: I'll bet you don't know the details of it.

Mr. Trudeau: How much do you bet?

Hon. W. G. Dinsdale (Brandon-Souris): A further supplementary question, Mr. Speaker, on this important matter. When discussing this question with the Secretary of State, would the Prime Minister confirm-and he might consult the Minister of Veterans Affairs on this matter as well-whether the veterans preference still applies?

Mr. Trudeau: Mr. Speaker, I will ask the Secretary of State to have those consultations.
