

### NATIONAL PARKS

#### REQUEST THAT FEDERAL REPRESENTATIVE PARTICIPATE IN HEARINGS CONCERNING EASTERN SLOPES OF ROCKY MOUNTAINS OR SUBMIT DETAILED BRIEFS

**Mr. Joe Clark (Rocky Mountain):** Mr. Speaker, my question is for the Minister of Indian Affairs and Northern Development. Would the minister reconsider his refusal to accept the invitation of the Alberta Conservation Authority to have a federal parks representative sit on the panel at the hearings concerning the eastern slopes of the Rocky Mountains, which are dominated by national parks, and where proper hearings cannot succeed without the full co-operation and participation of the federal government?

**Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development):** Mr. Speaker, if I understand the situation correctly, these territories are outside the national parks. I do not see how I could interfere with the activities of the Alberta government, since I am myself so touchy whenever the Alberta government meddles with our affairs within the parks.

**Mr. Clark (Rocky Mountain):** Mr. Speaker, I would remind the minister that an invitation was issued by the province of Alberta, which indicates that they were not particularly concerned about jurisdiction—

Would the minister at least give an undertaking that the briefs that his department intends to submit will, despite his answer, be detailed and not general, and will give enough guidance about parks plans that the province and private citizens can make sensible plans of their own for development of that region?

#### REVIEW OF OIL AND GAS REGULATIONS—POSSIBLE CHANGE IN ROYALTIES AND LEASE RATES—REQUEST FOR DEBATE

**Mr. Randolph Harding (Kootenay West):** Mr. Speaker, I have a question for the Minister of Energy, Mines and Resources. Are the federal oil and gas regulations still under review and, if so, when will the review be completed, and will the royalties and permit and lease rates under the new regulations be substantially increased over the rates existing under the present regulations?

**Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources):** Mr. Speaker, they are still under review. Royalties for offshore oil development are one of the questions under discussion and negotiation with the five eastern governments at the present time, and until those negotiations are completed I would not anticipate that there would be any change in the regulations. The exact nature of the changes will be announced at that time.

**Mr. Harding:** In view of the statement in the Canadian trade journal, *Oilweek*, that the petroleum industry has had frank, open and understanding discussions with the government on the new oil and gas regulations, may I ask the minister if and when similar discussions on these regulations will be held either with this House or the appropriate standing committee?

**Mr. Macdonald (Rosedale):** Mr. Speaker, whenever the House wants to so order.
