analysis of this problem and has he established priorities for the allocation of boxcars to these points?

Mr. Lang: Mr. Speaker, I did bring to the attention of the Canadian Wheat Board the suggestion I had received from a number of places that there was an imbalance in the way the cars were being spotted. They are giving serious consideration to that matter, but prior consideration has to be given to making the very best use of equipment at this particular point in time, and the equity for all that will come through equal delivery opportunities will be a matter for adjustment later.

PROPOSED SHIPMENT OF ALASKAN OIL THROUGH STRAIT OF JUAN DE FUCA—GOVERNMENT POSITION

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, my question is for the Secretary of State for External Affairs and relates to the shipment of Alaskan oil through the Strait of Juan de Fuca, which some months ago the minister promised us he had only begun to fight. Some of us might feel that we want our money back, since there does not seem to have been any fight.

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, discussions are going on and have, of course, been going on more or less regularly between officials of the two governments and between the various departments concerned. This, as I told an hon. memebr who asked me the question the other day, is one of the first items on my agenda in my talks with Secretary of State Dr. Kissinger when he arrives here. So I can assure the hon. member that we still have a few things in reserve and that he should keep his bets on me.

Mr. Stanfield: Mr. Speaker, before making any decision with regard to bets, would the Secretary of State for External Affairs indicate the respective reaches and weights of himself and the Secretary of State?
