- 2. No. As the legislation permits only the payment of maternity benefit during the period in question, the requirements of capability and availability, necessary for regular benefit, are not issues to be considered.
- 3. Unemployed women may not receive regular benefit during the period that commences eight weeks before the expected date of confinement and terminates six weeks after the actual week in which the confinement occurs. As this period is set by legislation, and there are no exempting provisions, any change in the claimant's availability will not affect the duration. It should be noted that the specific problems arising from the application of the legislative provisions dealing with benefits for reasons of maternity, were extensively reviewed by a task force which, among other things, has recommended major changes. These, however, are subject to approval by the government and the final decision has not yet been made.

## Question No. 3,302-Mr. Cossitt:

Did the Department of Employment and Immigration hold a competition, number 402 for a CR-5 position, bearing the code number 0437-34-EIC-3133 and, if so (a) what were the names of those who applied under this competition and what were the names of those actually interviewed (b) has the position been filled and, if not, will immediate consideration be given to one of the applicants, Mr. James A. Windsor of 366 James Street East, Prescott, Ontario?

Hon. Lloyd Axworthy (Minister of Employment and Immigration): No such competition, bearing code number 0437-34-EIC-3133 has been issued by the Canada Employment and Immigration Commission/Department, and therefore, the Commission/Department is unable fo offer any comment.

# Question No. 3,684—Mr. Herbert:

- 1. Were public servants receiving the bilingualism bonus required to take a second test to determine their continuing eligibility for the bonus?
- 2. Is it the government's intention to introduce such a retesting procedure and, if so, at what time intervals?

# Order Paper Questions

Mr. Norman Kelly (Parliamentary Secretary to President of the Treasury Board): 1. Yes, a number of them were. Since April 1, 1980, bilingualism bonus recipients have had to be confirmed annually, at the time of their official employee performance appraisal, as still meeting the language requirements of their position in order to continue receiving bonus payments. The Language Knowledge Examination (LKE) can be used for this purpose under the following circumstances:

- (a) when there is no linguistically qualified supervisor to confirm the employee's eligibility;
- (b) if the employee is not exempted from further testing by the Public Service Commission as a result of demonstrated high proficiency in the second official language;
- (c) if the employee does not possess LKE results which fall within the one and two year periods of validity established by the Public Service Commission; and
- (d) if an employee does not agree with the supervisor's assessment, he or she may have recourse to an LKE
  - 2. See 1 above.

NUMBER OF PUBLIC SERVANTS RECEIVING BILINGUALISM BONUS

### Question No. 3,685-Mr. Herbert:

In each of the past five years, by province and by stated first official language of the individual, how many public servants were receiving the bilingualism bonus?

Mr. Norman Kelly (Parliamentary Secretary to President of the Treasury Board): The table below presents a breakdown by province (or by region where applicable), and by stated first official language of the individual, of the number of public servants which were eligible to receive the bilingualism bonus in each of the past five years.

In order to ensure consistency of the data supplied, figures for February, 1978, have been provided instead of those for December, 1977, as these were calculated by using slightly different criteria. Similarly, and as they are still eligible to receive the bilingualism bonus, employees of the Canada Post Corporation are included in the December, 1981 figures.
