

wise; said return to include—(a) the names of the persons who were found guilty; (b) dates of such sentences; (c) the crimes of which such persons were found guilty; (d) the nature of the sentences pronounced; (e) the names of the judges pronouncing the sentence, and (f) in what manner the sentence was carried out.

2. The number of persons, male or female, who have been found guilty, but for whom reprieve from the execution of the capital punishment pronounced against such persons, was issued during the said period of time; said return to include the names of such persons; the date of the sentence pronounced; the name of the crime committed; the nature of the sentence; the names of the judges who pronounced the sentence in each instance; the sentences which were commuted and the nature of such commutation, if any.

3. The names of all persons in Canada, for each province, and who, during the said period of time, have been found guilty, but whose sentences were mitigated; also, the names of such persons who obtained absolute pardon, giving in each case the nature of the offence of which they were found guilty, the date and nature of the sentence pronounced, and the date and nature of the mitigation of sentence.

4. The name of each criminal who, during the said period of time, appealed or caused to appeal to His Excellency the Governor in Council, requesting that he exercise his royal prerogative in granting pardon or in commuting sentence. Also, the date and nature of each of such sentences; the name of the locality where each of such sentences was pronounced; the crime committed, the date of the appeal made and the result of such appeal.
