AIB—REPORTING OF PRICE INCREASES

Question No. 323—Mr. Orlikow:

- 1. How many companies are required by the Anti-Inflation Board to report any proposed price increases and how many have filed such reports?
 - 2. What are the names of the companies who have not filed such reports?

Hon. Donald S. Macdonald (Minister of Finance): 1. Two hundred seventy-four companies are presently required to report proposed price increases in excess of two per cent for any given quarter. All compliance companies are restricted to raising their prices only once per quarter. As of September 30, 1976, 131 companies had filed prenotification reports with the Anti-Inflation Board. Approximately 1,000 individual applications were filed by this group of companies. Sixty-one of the companies required to prenotify had not filed reports thus signifying that they have not raised their prices by more than 2 per cent in any calendar quarter since the inception of the
