At the Foot of the Rainbow

BLUE FOXES ARE BREEDING NOW

First of These Pups Born in Captivity in the East Now on Fundy Co's Ranch

There will be a great deal of interest throughout the provinces in the announcement that blue foxes are breeding this year and that they are giving very large litters. Last season these animals did not breed and as the same care had been taken of them as was given to the blacks and crosses an impression was created that this species would never breed in the east. As a result, a few ranchers who had bought blues became rather disgusted with them. Now, however, there need be no further uncertainty. The first two litters ever born in this province arrived a few weeks ago at the Provincial Company's ranch at Renforth and consisted, one of them of nine pups, and the other of eleven. These pups are now running about and appear to be strong and healthy. In view of the large litters it is believed that these foxes will eventually prove very profitable to fur farmers. They are now worth roughly about one thousand dollars apiece. Percy Allsby, caretaker of the ranch, expects several other litters of blues in the near future.

ALL CANADA INTERESTED

Messrs. Keirstead & Mersereau Have Established Connections in United States Also.

Messrs. Keirstead and Mersereau, who have re-organized the Oulton ranch at Little Shemogue, report that they have had much success in floating this proposition. Mr. Mersereau has just returned from a six weeks' trip to Ontario and the Eastern States and reports that very deep interest is displayed in Upper Canada and in the New England section, in the fox business. In New York the industry has just begun to attract general attention and on Broad street near the Stock Exchange a New Brunswicker, a Mr. DeWolfe, has established a Canadian Fox Bureau which appears to be doing a very satisfactory business. Mr. Mersereau had good success on his trip, and states that up to the present \$150,000 of stock in this company has been paid for and that a total of approximately \$400,000 has been subscribed or underwritten. A very large portion of this has been placed locally. Naturally Messrs. Keirstead and Mersereau are greatly encouraged with the success of their proposition.

PRICES ARE BETTER THAN EVER BEFORE

Canadian Traders, Ltd. Have Constructed a Demonstration Station—Four Options Turned Over.

Canadian Traders Ltd. have turned over four options during the past few days, and report that high grade stock is better than ever before, prices ranging from \$13,000 to \$14,000 per pair. This report coincides exactly with information received from P. E. I. which is to the effect that prices are better than ever, with every indication of going higher.

Canadian Traders Ltd. also announce that they have decided to establish a demonstration, sales and boarding ranch across the river from Moncton. They will erect from twenty to forty pens separated by four feet alleyways, together with ten large pens with alleyways of eight feet width between each. A competent caretaker with assistants is now on the ground building the ranch.


TWENTY LITTERS OF BLACKS AND CROSSES

Fundy Company Have Not Lost a Pup—Struck Four Black Pups in Litters From Patch Foxes.

In the Fundy Fox Company's ranch at Renforth there are now twenty litters of silver black and crosses. This company has had a streak of luck in the fact that in two of the litters of four each, from crosses, were found four all black pups.

This occasionally happens and is one of the circumstances which makes the cross proposition so attractive to intending investors.
