All the outgoing trains are crowded, and most of the prominent men have already left Johannesburg.

London, Sept. 2.-The Pretoria correspondent of the Morning Post says: "President Kruger told a prominent Boer on Wednesday that war was practically certain. Every Boer is now armed with a Mauser, and has a hundred rounds of ammunition strictly for future use, with 40 rounds for practice. I am convinced that the reports of the Boers not being prepared are only a pretence, and they will strike a blow when it is least expected.

NOTED REGIMENT ORDERED TO BE READY. It is reported at Aldershot that the

First Royal Dragoons, under Lieut.-Col. Burn-Murdoch, is under orders to be in readiness in the event of hostilities in the Transvaal. The regiment, which figured at Waterloo, Balaclava and Sebastopol, has not left England since the Crimean war. AT PRETORIA.

Herr Fischer, the special envoy of the Orange Free State, has arrived here from Bloemfontein, and is consulting with the government on the situation. was not ready. TWO VERSIONS.

London, Sept. 2.-Last evening Mr. Joseph Chamberlain, issued the of the Transvaal dispatches of Aug. 18 and 21, and of the reply of the Imperial Government on Aug. 26. The publication is accompanied by a note emphasizing the advisability of making the corrected versions known, owing to the fact that an incorrect version has been published in Pretoria.

The Transvaal dispatch of Aug. 19 contains the proposals regarding the franchise which go upon the assumption that Great Britain will agree that the present intervention does not constitute a precedent, and will allow the suzerainty question to drop tacitly. The dispatch of Aug. 21 makes the proposal concessions expressly conditional upon Great Britain's undertaking not to interfere in the future affairs of the Transvaal, nor to insist upon a further assertion of the existence of suzerainty, and to agree to arbitration. The reply of the imperial govern-

ment, dated Aug. 28, declares that Great Britain declares that the proposals put forward as alternative to those of July 31 assume the adoption in principle of a franchise which will not be hampered by conditions impairing the usefulness, and which will assure immediate representation. With respect to intervention, the imperial note says that the government can-not debar themselves from their rights under the conventions, nor deter themselves from the obligations of a civilized power to protect its subjects abroad from injustice. The note concludes by reminding the Transvaal that other matters exist, which the grant of a political franchise will not settle, and which are not the proper subjects of arbitration. These. the note declares, it will be necessary to settle concurrently with the questions already under discussion, and they will form, with the questions of arbitration, propert subjects for the proposed Cape Town conference

The Pretoria version of the imperial reply was that Mr. Chamberlain was unable to consider the Transvaal's proposals as an alternative to a joint commission of inquiry.

HOPING FOR PEACE. Reports received at Cape Town from various outlying districts of the Transvaal describe them as being in a state of excitement. The burghers, it is said, are watching the developments keenly, but the majority of them hope for a peaceful solution of the crisis. There is a general exodus of British subjects from the larger towns. Orders have been issued to the commandants and field cornets to have themselves and the burghers in readiness in the event of an outbreak of hostilities.

A GAME OF PATIENCE.
