"Rupert of Hentzau," as presented at the Grand yesterday afternoon and evening to large audiences, proved an acceptable holiday offering. The play hardly scores the unqualified success that fell to the lot of its predecessor, "The Prisoner of Zenda," but this is probably owing more to the novelty and originality of the idea having be come dulled than through any inherent fault of the play itself. The present company is in the main equal to the demands made upon it. Mr. Harry Leighton, who takes the double role of King Rudolf and Rudolf Rassendyl, gives a clever and commendable rendition of a trying part. Not the least valuable feature of his historic equipment is his voice which is well modulated and pleasingly clear, and over which he has such perfect control. It is noticed that Mr. Leighton dispenses with the wig required to make the King and his English cousin meet the popular conception of the "red Elphbergs." It is an omission like this that makes a play, founded on a book which has been so widely read, lose some of its satisfying quality for those who have perused the story. Mr. Cecil Owen in the title role did not realize the possibilities of the part, for he falled to portray the smooth, mocking deviltry of Count Rupert's villainy. Miss Ethel Barrington as Queen Flavia, was also woefully weak at times. George B. Miller was excellent as the faithful old soldier, Col. Sapt, and the minor roles were filled with acceptance.

Charges 107, 108 109 and 123, concerning alleged treating at Shain's hotel, Pottersburg, were then taken up.Judge Maclennan said that on account of the unnecessarily verbose language which the charges were clothed, he must ask counsel for the petitioners to save the court's time by setting forth in plain English the purport of the

Mr. Meredith explained that the first three charges concerned the supplying of liquor to voters at Shain's hotel, while the last charge covered the payment of money to Mr. Shain for the liquor dispensed. Hiram Shain, proprietor of Shain's
