

Responsive, Not Retallatory. The Boston Journal hopes that Canada will not continue such a course as will force President Cleveland to take action under the so-called Retaliation Act. But should this be necessary, it says, the policy adopted should be responsive, rather than retaliatory. Our American contemporary thus explains: That is our Government should, as far as

American contemporary thus explains: That is, our Government should, as far as possible, respond to the policy of Canada, rather than to adopt the harsher policy of re-taliation. Canada has refused out fishermen the privilege of landing their fish at Canadian ports under bond to be shipped to the United States on the ground that the treaty of 1818 precides trading by fishing vessels in Canadian ports. As the landing of fish by fish-ing vessels is the only trade in fish which we can have refuses our fishing vessels that privi-lege, that we respond by refusing Canadians the privilege to ship their fish to the United States on vessels of any kind or by rati-this would be responsive action, because States on vessels of any kind or by rail. This would be responsive action, because it would simply be the adoption of Canada's construction of the rights of lishermen. It was upon this theory that the contest over the two measures presented resulted in favor of the Edmanda bill. The bill presented by Mr. Bel-mont was purely a measure of retaliation. Mr. Belmont advocated it as such, and those who opposed it opposed it on that ground. The Edmunds bill was what may be called a responsive measure-one which applies the Canadian policy in regard to American fisher-men to Canadian fishermen and fish. Mr. Belmont's bill was beaten because its object was retaliation in its broadest and most offen-sive sonse. The other was adopted because the majority in both branches of Congress was opposed to the theory of general non-inter-
