

Mr. Mackenzie King, a Member of the King's Privy Council, laid before the House,—Copies of Emergency Orders in Council passed under the provisions of the War Measures Act, between September 12, 1939 and January 17, 1940, bearing on the War in Europe, as follows:—

Order in Council P.C. 2435, dated September 12, 1939: regulation regarding the requisitioning of property other than land.

Order in Council P.C. 2629, dated September 11, 1939: giving authority to capture and seize all German ships.

Order in Council P.C. 2635, dated September 11, 1939: authorizing regulations *re* sale and regulations of Codeine.

Order in Council P.C. 2637, dated September 18, 1939: appointing E. H. Coleman, K.C., LL.D., Under-Secretary of State, as Chairman of the Voluntary Service Registration Bureau, set up by Order in Council P.C. 2620, dated September 9, 1939, as amended; and appointing Major J. F. Cummins, Miss E. E. Saunders, Major M. F. Gregg, V.C.; as Members thereof.

Order in Council P.C. 2638, dated September 14, 1939: authorizing ships of the Royal Canadian Navy to co-operate with the Royal Navy.

Order in Council P.C. 2646, dated September 14, 1939: rescinding Order in Council P.C. 2580, dated September 7, 1939, which authorized the appointment of Mr. Oswald Mayrand, former Director of the Canadian Press, Montreal, as a Member of the Censorship Co-ordination Committee.

Order in Council P.C. 2652, dated September 14, 1939: authorizing compensation for persons engaged in postal censorship.

Order in Council P.C. 2653, dated September 14, 1939: establishing regulations respecting entry of enemy aliens.

Order in Council P.C. 2654, dated September 12, 1939: establishing a Committee of Public Information.

Order in Council P.C. 2677, dated September 14, 1939: creating a Special Reserve of the Royal Canadian Air Force.

Order in Council P.C. 2682, dated September 14, 1939: establishing Prize Court Rules.

Order in Council P.C. 2696, dated September 15, 1939: establishing the War Supply Board.

Order in Council P.C. 2697, dated September 15, 1939: appointing Gordon W. Scott, Esquire, of Montreal, and Watson Sellar, Esquire, Comptroller of the Treasury, Joint Directors for the purpose of making plans regarding the personnel, accommodation and general organization of the War Supply Board.

Order in Council P.C. 2698, dated September 14, 1939: establishing an Economic Advisory Committee.

Order in Council P.C. 2709, dated September 15, 1939: authorizing Defence Purchasing Board Regulations *re* contracts.

Order in Council P.C. 2716, dated September 15, 1939: creating Foreign Exchange Control Board and Regulations.
