Hon. Mr. HAGGART. We want to have it before the Interior estimates come up.

The POSTMASTER GENERAL. There will be no delay.

RAILWAY STATION AT ALBERTON, P.E.I.

And a limited issue covering New England states and all points on the Intercolonial Railway are on sale at all other booking stations, except at Wellington, Miscouche and Royalty Junction.

LONGSHOREMEN'S STRIKE IN MON-TREAL.

Mr. F. D. MONK (Jacques Cartier). Before the Orders of the Day are called, I wish to ask: Has any action been taken by the government in regard to the strike prevailing among the longshoremen at Montreal, and which has been creating so much disturbance in commercial operations there? Has anything been done by the government, and if so what has been done?

PRIME MINISTER (Rt. Hon. Sir Wilfrid Laurier). My hon, friend (Mr. Monk) is quite aware that the government has no authority to interfere in this matter. The law provides for the existing conditions, and the law is being followed. local authorities have thought it advisable to call upon the military authorities to give them assistance, and all the assistance that it was in the power of the military authorities to give has been rendered.

Might I ask the right hon. gentleman, if there is any foundation for the statement that His Worship the Mayor of Montreal has appealed to the government, that the expenditure in connection with the calling out of the militia force shall be borne by the government and not by the municipality of Montreal? If the Mayor of Montreal has made that request, has the government given any reply?
