Mr. Pearson: We do not know the details of the shipment. I understand it was medical supplies and that 90 per cent of the money used for this purpose did go to North Viet Nam.

Mr. R. W. Prittie (Burnaby-Richmond): May I direct a related question to the Prime Minister. On January 9 I asked the Secretary of State for External Affairs whether the Canadian government had received from the Canadian Quakers a request for aid in the provision of medical supplies to both North and South Viet Nam. Has such a request been received and, if so, what reply has been given?

Mr. Pearson: Perhaps I can answer that question, since it was addressed to me. I can inform the hon, member that such a request from the general secretary of the Canadian Friends service committee was received last month by an official of the external affairs department and was acknowledged at that time. The matter is now under consideration, and a substantive reply will be made to the general secretary of the committee in the very near future.
