# VETERANS LAND ACT

## CONSIDERATION BY SENATE OF BILL EXTENDING EXPIRY DEADLINE

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, I rise on a point of order. Yesterday members of all parties in this House gave unanimous consent wherever it was necessary and co-operated thoroughly so that Bill C-17 could be passed through all its stages. Bill C-17 is the bill that extends the Veterans Land Act which otherwise would expire, or at least certain of its provisions would expire, on March 31.

I think it is generally understood that one of the reasons for yesterday's co-operation was so that this bill could be dealt with in the other place, finally passed and given Royal Assent before March 31. I have discovered this morning, Sir, that the Senate adjourned yesterday afternoon until eight o'clock Tuesday evening.

Some hon. Members: Shame!

Mr. Paproski: Abolish the Senate.

Mr. Knowles (Winnipeg North Centre): I realize, Sir, that this House has no control over the other place unless we take the suggestion of my good friend from Edmonton Centre. However, the leader of the Senate is a member of the cabinet and therefore I believe it would be the will of this House to call upon the government to suggest to the leader of the government in the other place that that House should meet today or on Monday to deal with this legislation. I realize that no veteran will lose a grant because of this delay of two or three days, but the Senate knew the Veterans Land Act was coming to it—it is on the record—and its action is an insult not only to the members of this House but to the veterans of Canada.

ANNOUNCEMENT OF PARTICIPATION BY CANADIAN DELEGATION IN CEREMONIES COMMEMORATING THIRTIETH ANNIVERSARY OF NORMANDY LANDINGS

Hon. Daniel J. MacDonald (Minister of Veterans Affairs): Mr. Speaker, I am very pleased to announce that an official Canadian delegation will participate in the events in France this June commemorating the thirtieth anniversary of the Normandy landings. The ceremonies, organized by the Comité du Débarquement, have the approval and the support of the government of France.

The Canadian delegation will be headed by myself and the ambassador to France, the Hon. Léo Cadieux. It will include representatives of parliament, the armed forces, senior D-Day commanders, representatives of veterans organizations, and D-Day survivors from all the participating army units and from the Royal Canadian Navy and Royal Canadian Air Force.
