IMPACT OF UNITED STATES EMBARGO ON IMPORT OF CANADIAN MEAT—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

That the House direct the Committee on Finance, Trade and Economic Affairs to assess the impact of this measure on hog producers, make proper recommendations and report to the House on or before March 31, 1975.

SUGGESTION GOVERNMENT NOT PARTICIPATE IN SYNCRUDE UNTIL ENVIRONMENTAL PROBLEMS SETTLED—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Andy Hogan (Cape Breton-East Richmond): Mr. Speaker, I rise on a matter of urgent and pressing necessity under the provisions of Standing Order 43. In light of recent indications that the pollution control technology envisaged for the Syncrude project, in which the federal government is now involved, will be inadequate to meet federal environmental standards, and in view of the fact that meeting these standards may involve substantial extra costs over and above those already contemplated, I move, seconded by the hon. member for Sault Ste. Marie (Mr. Symes):

That the government be instructed to inform the other principals of Syncrude that it is unwilling to participate in the project until it is satisfied that adequate provision has been made for environmental control and until it has received firm cost estimates for any modifications necessary to meet such standards.
