## INHUMAN TREATMENT OF TAIWAN NATIONALS - MOTION UNDER S.O. 43

Mr. Tom Cossitt (Leeds-Grenville): Madam Speaker, I rise on a matter of urgent necessity concerning Dr. C. M. Kao, general secretary of the Presbyterian Church in Taiwan, who has recently been seized by the Taiwanese police, and also with respect to the fact that a member of his office staff was arrested last January and has been held in solitary confinement ever since, reportedly under the most inhuman treatment and with attempts to force her to confess to whatever she is told to say. I would move, seconded by the hon. member for Winnipeg-Assiniboine (Mr. McKenzie):

That the House respectfully requests the Secretary of State for External Affairs to review all available details of this case in order to determine whether a severe violation of human rights as defined under the Helsinki agreement, and police state tactics, have and are taking place, and that the minister be respectfully asked to take whatever action may be within Canada's means to assist these individuals if a violation of human rights is indeed determined.
