TRANSFER OF CANDU TECHNOLOGY

Hon. Michael Wilson (Etobicoke Centre): Mr. Speaker, my question is to the Minister of International Trade and is supplementary to the questions put by my colleague earlier. The bafflegab the Minister used in his answer to my colleague's question indicates that he either does not know what is going on or he is trying to hide his ineptitude and that of his predecessor in not completing one Candu sale, and presiding over the collapse of another during their term of office. Would the Minister state clearly that any transfer of technology will be clearly tied to the continued use of Canadian suppliers and engineers, and will not simply give away the store and totally undermine the future of that industry with this single deal in order to save his political hide?

Hon. Gerald Regan (Minister for International Trade): Mr. Speaker, I cannot imagine a higher degree of ineptitude than to suggest we should do the negotiating for possible sales of Candus here on the floor of the House. I want to reject most heartily the idea that I outline on the floor of the House exactly the terms I would put on the table or that I would have as the bottom line in any of the negotiations currently under way for the sale of Candus.

TERMS OF SALE TO KOREA

Hon. Michael Wilson (Etobicoke Centre): Mr. Speaker, that is a totally ridiculous response and totally ignores the question I am asking. The industry is interested in saving its jobs and its future. The AECL is interested in selling heavy water and engineering in a way that will sell out the future of the industry in Canada. This Government is interested far more in saving its own political hide in the short-term, and is not thinking of the future of the industry.

Is the Government tieing this latest attempt to hide its embarrassment at not selling any Candus to a firm commitment by Korea to purchase on a long-term basis Candus for Korean domestic requirements and in a way that would use Canadian suppliers and engineering talent?

Hon. Gerald Regan (Minister for International Trade): Mr. Speaker, I do not know whether the Hon. Member has much

business experience, but I want to assure him that, whatever his position may be in relation to approaching sales, I am not the least bit interested in any political hide when it comes to the question of creating Canadian jobs through the sale of Canadian goods and services, including Candus. My approach to the question will be that of maximizing our sales in the best interests of Canada, and not in relation to political benefits about which the Hon. Member seems to be concerned.
