I hope that it has the desired effect on the Romanian government.

BUSINESS OF THE HOUSE

Mr. Albert Cooper (Parliamentary Secretary to Government House Leader): Mr. Speaker, I believe you will also find consent for the following motion as there has been discussion among the three parties. I move:

That, immediately following the vote on Bill C-28, the Right Hon. Secretary of State will make a statement concerning events in Panama and that his statement shall be followed by one speaker from the Liberals and one speaker from the NDP; that both speakers from these two parties will be given adequate time to respond to the statement and will not be restricted by the usual restrictions which apply to ministerial statements;

and that, following these three statements, the following adjournment motion will be deemed adopted:

That, when the House adjourns today it stand adjourned until one o'clock p.m. on Monday, January 22, 1990, provided that the Speaker may recall the House at anytime before that date for the sole purpose of Royal Assent; and

that, the number of allotted days in the period ending not later than March 26, 1990, be reduced from nine to eight; and

that, the mid-winter break week for 1990, when the House will not sit, be from the time of adjournment on Friday, February 23 to one o'clock p.m. on Monday, March 5, 1990.

Mr. Speaker: Does the hon. member have the unanimous consent of the House to move the motion?

Some hon. Members: Agreed.

I take it that the House knew what it was doing then and that we would not have to come back and do anything else but comply with the adopted motion as agreed.

Mr. Cooper: Mr. Speaker, I am sorry. The motion as I read it was passed to the table officers. I do not have a copy in front of me to verify the wording. Of course, what we were looking for was to come back at the usual time on Monday, January 22, 1990, for the usual procedures.
