(f) The Special Advisor's travel costs allowed him to meet 1,600 individuals across Canada.

## \*Ouestion No. 34-Mr. Gauthier:

For each of the next ten years, what is the estimated additional cost, if any, that would be incurred by the Public Service Superannuation Account (PSSA) if married PSSA retired pensioners over the age of 60 were permitted to split their PSSA pensions with spouses 60 years of age or older along the lines permitted by the Canada Pension Plan?

Mr. Albert Cooper (Parliamentary Secretary to Minister of State and Leader of the Government in the House of Commons): Time required to prepare this answer: 3 hours and 55 minutes

Approximate cost: \$71.

I am informed by the Treasury Board Secretariat as follows:

When a pension payable to a contributor under the Canada Pension Plan (CPP) is split, a portion of the contributor's monthly pension is simply paid to the contributor's spouse. This portion is treated for all purposes as though it were being paid to the contributor. Thus, if the contributor dies before the spouse, the amount payable to the spouse ceases to be paid. If the spouse dies before the contributor, the amount payable to the spouse reverts back to the contributor. In other words, there are no additional benefits, and therefore no additional costs, when a CPP pension is split.

Similarly, there would be no additional costs for the Public Service Superannuation Account if married pen-

sioners were permitted to split their pensions along the lines provided under the CPP. It should be noted, however, that proposed amendments to the Income Tax Regulations (which were released in draft form by the Department of Finance in December 1989) prohibit the registration of a pension plan which permits pension splitting other than on marriage breakdown.
