NEED FOR POLICIES TO IMPROVE AGRICULTURAL AND HORTICULTURAL INDUSTRIES—MOTION UNDER S.O. 43

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, as is my wont, I rise today, the first day of spring, under the provisions of Standing Order 43, on a matter of urgent and pressing necessity related to Canada's horticultural potential, as symbolized by the daffodils from my riding of Esquimalt-Saanich which are available in the lobbies to all hon. members.

Some hon. Members: Hear, hear!

Mr. Munro (Esquimalt-Saanich): In view of the fact that this government has failed to develop programs and policies that provide equity and equality in the area of trade and tariffs for agricultural producers, and has failed to develop programs and policies that ensure growth and development throughout the entire Canadian food system, I move, seconded by the hon. member for Elgin (Mr. Wise):

That the government move immediately to implement and amend the tariff motion to provide much needed tariff measures for producers this season, 1979, including commodity by commodity surcharges and surtaxes, and that measures be introduced to ensure a greater degree of self-sufficiency in the Canadian food system, thereby reducing the reliance of Canadian consumers on imported food supplies.

Mr. Speaker: Such a motion can be presented for debate only with the unanimous consent of the House. Is there unanimous consent?
