Sect. 9, of 20 V. c. 28, repealed. **5.** The ninth section of "The Prison Inspection Act, 1857," is hereby repealed, and the following section shall be substituted for such repealed section, and shall be read as part of the said Act:

New Section substituted. "It shall be lawful for the Governor at any time, on report 10 of the Inspectors, in his discretion, to order any offender sentenced under the fifth section of this Act, or any Convict transferred to either of the Reformatory Prisons of this Province, under the seventh section of this Act, to be removed from 15 either of the said Reformatory Prisons, as incorrigible, and in every such case the offender or Convict shall be liable to be confined in the Provincial Penitentiary for the remainder of the term of imprisonment for which he shall have been originally sentenced in such Reformatory Prison or in the Provincial Penitentiary. 20
