Student control needed over housing policy

The proposed changes in graduate residence admission policies announced last week by a committee top-heavy with representatives from the administration, are to say the least, a disappointment.

Not that changes in the admission policy were not called for. The red-tape headaches that anyone who has applied for grad residence knows about, are long overdue for review. The housing regulations' discrimination against gay couples demanded immediate action.

Unfortunately the committee concerned itself with neither of these problems.

They concerned themselves with things like a proposal that anyone who owed a penny to any sector of the university be disqualified from residency.

Come off it gang. A landlord is a landlord is a landlord. Will I get evicted from my apartment in High Park because I haven't paid a parking ticket? Eligibility for graduate residence and outstanding parking, library or other fines are separate matters.

The committee decided that formally married students would be given priority over two students cohabitating. We wish they'd explain themselves, explain why a couple with a marriage license is somehow more in need of graduate residence accomodation than one without?

And in what seems to be an attempt to counter criticism levelled against grad residence housing regulations regarding gay couples, they decided that tenants of the same sex would be able to share any type of graduate accomodation (they were previously banned from furnished one-bedroom apartments).

Well, that's a step in the right direction, but it still means that gay couples - who find it difficult to get married in our society have to wait in line behind married heterosexual ones.

Adding insult to injury, under their proposed changes even if you make it into grad residence, you will be faced with an eviction notice in four years. No matter that your Phd has another two years to run, no matter that you've been a model tenant for those four years, you've got to look for a new place.


But then it's not surprising that the committee's proposals are so poor. On the seven member committee, there were only two grad residence tenants, Dave Fleet and Bill McMaster from the York University Tenants' Association. These two attempted to instill some sanity into the committee's proposals, but met with little success, facing rather heavy odds.

That there must be some guidelines governing residency in our graduate residences is of course beyond question. The question is, who should decide?

The decision must be made by a body that is representative of the York community and is chosen democratically. It only makes sense.

Who better knows the problems and requirements of oncampus residency than on-campus residents?

The concept we're talking about is as old as it is simple: representative democracy. And history has proven that this lecision-making is always superior to arbitrary nondebatable dictat's handed down from on high.



in breaking newspaper pact

It's generally not a good idea for a newspaper to talk about itself but, it is important for papers to comment when something is done wrong. And something was done wrong directly concerning this paper.

The Council of the York Student Federation (CYSF) voted to break a three year agreement with this paper and cut back Excalibur's grant for this year by \$7,000. In 1974 following an attempt by a nasty student council president to veto the Ex-calibur staff's choice for editor it was decided something must be done to preserve the autonomy of the paper, to guarantee that the CYSF could not blackmail the paper with reduced grants everytime it took a stand in opposition to the federation.

This was a good idea and one which two student councils have respected despite huge disagreements with the newspaper in the past.
