Reported from Committee and read first time, 88; committed, 99; considered and reported with an amendment, 100; motion to refer back to Committee to amend by adding a clause guaranteeing the interest on a loan of £100,000, neg'd. on division, *ib.*; further motion to refer back to Committee to amend, by adding a clause binding all proprietors by the Award of the Commissioners, neg'd on division, *ib.*; Report of Committee affirmed on division, *ib.*; Read third time 110; motion that the Bill do pass, *ib.*; motion of amendment to defer three months, neg'd on division, *ib.*; main motion affirmed on division, 111; passed by the Council, 163; assent, 167.
19. (From the Council,) An Act to promote vaccination. Brought down and read, 94; Mr. Speaker acquaints the House that the Bill relates to money matters, and that the House cannot consistently with its privileges consider the same, *ib.*; House approves of the principles of the Bill, and appoints a Committee to prepare a similar one, *ib.* See Bills, No. 27.

21. Small Debts; to alter and amend the Act relating to the recovery of. Reported from Committee, and read first time, 104; committed and reported with amendments, 106; motion to refer back to Committee to amend by extending relief to insolvent debtors for debts of certain amounts, neg'd. on division, 106; further motion to refer back to Committee to amend by extending relief to insolvents for any debt, damages or costs, affirmed, *ib.*; further considered, *ib.*; motion to receive report, *ib.*; motion of amendment to defer three months neg'd. on division, and main motion affirmed, 107; third reading, 127; motion to add rider, which is read, *ib.*; motion to read second time, neg'd. on division, 127, 128; Bill passed, 128; by the Council, 138; assent, 168.
22. To authorize the Government to prohibit the exportation of military or naval stores and provisions. Reported from Committee and read first time, 107; committed, 116; passed, 118; by the Council, 134; assent, 168.
23. Naval Service: For vesting all estates and property occupied by or for the Naval Service of the United Kingdom of Great Britain and Ireland, in the Lord High Admiral or the Commissioners for executing the Office of Lord High Admiral of the said United Kingdom, for the time being. Reported from Committee and read first time, 108; Rule suspended, and Bill committed, 109; passed, 128; by the Council, 157; assent, 168.
24. Steam Communication: To encourage steam communication between Charlottetown and certain parts of the Hillsborough and Elliot Rivers. First reading 110; motion for second reading, evaded by motion of amendment to defer three months, 129.
25. Inland Posts: To repeal the Act made and passed in the 24th year of the reign of Her present Majesty, Chapter 9, and to further amend the Act for the transfer of the Inland Posts within Prince Edward Island. First reading, 110; committed, 120; passed, 129; by the Council, 138; assent, 167.
26. City of Charlottetown; in amendment of the Act to incorporate the. First reading, 110; motion for second reading, evaded by motion of amendment to defer three months, 128.
27. Vaccination; to promote. Reported from Committee and read first time, 115; committed, 158; considered, 159, 160; passed, 162; by the Council, 166; assent, 168.

First reading, 115; motion for second reading, 117; motion of amendment to defer three months, neg'd. on division, *ib.*; read a second time and committed, *ib.*; passed, 129; by the Council with amendments, 157; amendments read thrice and agreed to, *ib.*; assent, 168.
