Mr. J. P. Deschatelets (Maisonneuve-Rosemont): May I ask a supplementary question. Would the Minister of Justice be kind enough to say on what date the informations for the search warrants were registered at the court house?

Mr. Fulton: Mr. Speaker, I do not have that information. It seems to me it is a matter of detail which perhaps is not entirely appropriate to be asked and answered on the orders of the day. If the hon. member wishes to put the question to me in a manner in which I can get the information and bring it in, I will be glad to do so.

Mr. Deschatelets: Would the minister take notice of my question?

INQUIRY AS TO BOOKLET ON COASTGUARD SERVICE

On the orders of the day:

Mr. L. R. Crouse (Queens-Lunenburg): I would like to direct a question to the Minister of Transport. Now that the Conservative government plans to implement a Canadian coastguard, using existing ships in government departments for the protection of Canadian seamen and fishermen, will the minister tell the house when we may expect a new booklet to be distributed outlining this service for the guidance of our fishermen?

It will, in fact, be the responsibility of these new officials to develop this program by whatever suitable means are available.
