CANADIAN FLAG

INQUIRY AS TO INTRODUCTION OF RESOLUTION

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, I should also like to ask a delicate question. Would the Minister of Justice, the house leader, tell the house what are the present plans as to the day when the two flag resolution will be introduced? We should like to know in advance.

Hon. Guy Favreau (Minister of Justice): Mr. Speaker, there are no plans for introducing a debate on any two flag resolution.

Mr. Diefenbaker: Mr. Speaker, in view of the fact that the Minister of Justice is apparently unaware of what the rest of the government is doing, may I ask him this. When will the resolution which provides for a flag bearing three maple leaves, as well as the union jack, be introduced?

Mr. Favreau: Mr. Speaker, with regard to the order paper I might say it is my belief, subject to a definite announcement tomorrow, that the debate on—

Some hon. Members: Oh, oh.

Mr. MacEwan: What a house leader.

Mr. Favreau: I said subject to confirmation tomorrow.

Mr. Starr: You mean subject to Paul Martin.

Mr. Favreau: The resolution which is on the order paper concerning a distinctive flag for Canada will commence to be dealt with on Thursday.
