ADJOURNMENT FOR CHRISTMAS RECESS UNTIL JANUARY 12

Mr. Macdonald (Rosedale): Mr. Speaker, I move:

That when the House adjourns at the conclusion of the sitting on Friday, December 19, 1969, it shall stand adjourned until Monday, January 12, 1970, at 2.00 o'clock p.m. provided always that if it appears to the satisfaction of Mr. Speaker, after consultation with Her Majesty's Government, that the public interest requires that the House should meet at an earlier time during the adjournment, Mr. Speaker may give notice that he is so satisfied, and thereupon the House shall meet at the time stated in such notice, and shall transact its business as if it had been duly adjourned to that time; and

That, in the event of Mr. Speaker being unable to act owing to illness or other cause, the Deputy Speaker or the Deputy Chairman of Committees shall act in his stead for the purpose of this order.

Mr. Winch: Mr. Speaker, may I direct a question to the Minister of National Defence (Mr. Cadieux). Do we now have his assurance that the "Yukon" will be flying tomorrow, because half an hour ago I told my wife that it would.
