

*Jury Service for Women*

Mr. Speaker, today we deplore the creation of such a body, which is to be called the Security Planning and Research Group.

The terms of reference of that service, if they remain as indicated by the Solicitor General, seem adequate to us, but we insist that that group have no active function whatever within our Canadian police forces. The advisory role of that group must be well defined, and we believe that it will have to remain of a strictly advisory nature.

Since the establishment of that group has become practically indispensable owing to the period of carelessness which has prevailed for too long in our governments in connection with their commitments toward the population, we therefore welcome although we do not like it this step toward police re-organization in Canada. Prevention is better than cure.

However, if that assertion fits perfectly the announcement of the Solicitor General, it applies all the more to the rationale behind the government's decision to establish the Security Planning and Research Group. The Canadian people are getting fed up with unemployment, unfulfilled election promises, trips abroad, etc.

The setting up of that government branch shows pretty well where we are after several years of gloomy administration under this government and previous ones. What a pity! It seems to me that we will not get anywhere as long as we do not realize that any basic reform must be founded on charity and on the individual human being.

**LABOUR CONDITIONS****LAY-OFFS BY GENERAL MOTORS—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43**

That this House requires the government to take immediate steps to ensure that Canadian jobs are not sacrificed to provide jobs for workers in other countries.

This House is of the opinion that the government took the correct stand in expressing objections to the proposed nuclear device test scheduled to be conducted by the Atomic Energy Commission of the United States of America and therefore urges the government to raise this proposed nuclear device test in the United Nations forthwith in the hopes of developing a world wide concern about the moral issue of the United States of America adding further to the nuclear arms race and contributing to a potential environmental and geographic disaster.
