The maintenance of law and order on the grounds at Parliament Hill and protection of the government securities vault East Block; ensuring freedom of access to Parliament Hill by Senators and Members of Parliament; protection of the Prime Minister and members of his immediate family; investigation into any threats that may be made against Ministers of the Crown.
