That, on a day designated by a minister of the Crown, the business taken up shall be the second reading, consideration in committee of the whole, report stage and third reading of the bill based upon the motion for interim supply and that, at fifteen minutes before the ordinary time of adjournment on that day, proceedings then in progress shall be interrupted and every question necessary for the disposal of the said bill shall be put forthwith successively, without amendment or debate;
