That Bill C-47, be amended by adding immediately after line 43 at page 23 the following:

"28. Not later than five years after this Act is proclaimed into force, such committee of the House of Commons as may be designated or established for the purposes of this section shall

(a) review the provisions of this Act relating to reconciliation and support orders; and

(b) within a year after the review is undertaken or within such time as the House of Commons may authorize, submit a report to the House thereon, including a statement of any changes the committee would recommend."
