PURCHASE OF AIRCRAFT FROM SOUTH AFRICA BY WARDAIR

SHIPYARDS

NEED FOR RATIONALIZATION POLICY

Mr. Louis Plamondon (Richelieu): Mr. Speaker, Canada's shipyards are facing a serious crisis. It is becoming increasingly clear to all parties concerned, whether they belong to the public sector, the private sector or labour, that a rationalization policy is necessary. I hope such a policy will be based on the fundamental principle this Government has always defended, namely that of free enterprise. In fact, any other approach would merely serve to extend the life of the "lame ducks", to the detriment of shipyards that are already reasonably competitive.

Mr. Speaker, in the past, Governments that were more concerned about their voters than about providing this country with sound economic management had no qualms about controlling the way government contracts were awarded. This solution is no longer acceptable today, and I think that from now on, the process of awarding contracts should be based on the free market system and thus on the fundamental principle, in a capitalist system, of having the right to bid on a contract.

Mr. Gilles Bernier (Beauce): Mr. Speaker, for 20 months this Government has been taking some very important measures in the agricultural industry.
