Hon. Jeanne Sauvé (Minister of Communications): Mr. Speaker, I think the hon. member is not well informed about the frequency of meetings of communications ministers. A meeting was held March 29 and another one is scheduled for next March.

Regarding the negotiations proposed by Quebec communications minister O'Neill, I acknowledged his proposal and I am prepared to enter into negotiations with him on a bilateral basis, as it has already been done with other provinces such as Saskatchewan, Manitoba and Ontario.

As for these bilateral negotiations, I think the hon. member should understand that these are extremely complex issues, they arise in a context which varies from one province to another and must be dealt with on a bilateral basis. It would of course be desirable to reach similar agreements with all provinces. It is my objective but I am not sure I will reach it.

BELLA BELLA, BRITISH COLUMBIA—REQUEST FOR ASSISTANCE IN REPAIRING DAMAGE

Is the Minister aware of the economic disaster and tragedy which struck the remote village of Bella Bella on the coast of British Columbia? For the minister's information, in case he has not heard, power was lost for a week, freezing temperatures burst pipelines and a flood took place. In addition Bella Bella has just lost its hotel. Can the minister assure me that efforts will be made by his department to assist the residents of Bella Bella as they seek to rebuild and replace the buildings and facilities they have lost?

LOWER CHURCHILL FALLS POWER PROJECT—FEDERAL PARTICIPATION IN DEVELOPMENT

Mr. Jack Marshall (Humber-St. George's-St. Barbe): Mr. Speaker, my question is to the Minister of Energy, Mines and Resources. His colleague, the Minister of Employment, has repeated on a number of occasions the type of projects that would provide long-term employment, for example, the lower Gull Island site in Labrador. I wonder if the minister would indicate if he has had any further discussions with the province of Newfoundland? Have there been any new proposals, and has he indeed participated in discussions between that province and the province of Quebec with regard to future developments?

Hon. Alastair Gillespie (Minister of Energy, Mines and Resources): Yes I have talked to the minister of mines and energy for the province of Newfoundland, Mr. Speaker, with respect to this particular project. I have asked him if he would put forward a proposal to me and to the federal government indicating what the priorities of the Newfoundland government are for the development of the Lower Churchill Falls site. Also how they relate to his government's priorities with respect to a settlement of the outstanding dispute with the province of Quebec. He has undertaken to do so, and I would expect to receive a letter from him some time next week. I believe it was promised to me before Christmas.

An hon. Member: Don't count on the Christmas mail.

Mr. Marshall: I realize the amount of money allocated in the FLIP program would not go very far towards full development. I wonder if the minister has any allocation of that funding? And is there funding going to such a project for the preparatory work which might help out in the future?

Mr. Gillespie: Mr. Speaker, should such funds be made available, I am sure that the Minister of Employment would want to make that announcement, and I will leave that to him.
