## BILLION IN SEA WAR RISKS.

McAdoo Says Federal Policies on Ships Number 13,844.

Washington, Jan. 10.—Secretary McAdoo has announced that the Bureau of War Risk Insurance since its creation on Sept. 2, 1914, to Dec. 31, 1917, had issued insurance of more than \$1,000,000,000 on the hulls and cargoes of American vessels, as follows:

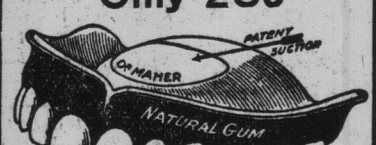
Sept. 2, 1914-Dec. 31, 1915. \$192,200,000  
 Jan. 1, 1917-Dec. 31, 1917. \$19,834,445

Total. \$1,001,637,885

The total number of policies written was 18,844. The total premiums received by the government have exceeded the total losses by \$18,889,400.86.

"These figures," said Mr. McAdoo, "indicate the great service which the bureau has rendered the country, both before and after the declaration of war. In addition to the large amount of insurance issued, the reasonable premiums charged by the government have had a large influence on the rate of private companies."
