Hon. FRANK OLIVER (Minister of the Interior) :

1. Applications for half-breed scrip were made by the following persons: Norman Ouellette, Frank Ouellette, John Boucher, Joseph Delorme, P. Ducherne and Madame Urbain Delorme.

There is no record of any applications by Rosalie Lesperance or Adeline McIvor. The applications of Norman Ouellette,

Frank Ouellette, John Boucher, Joseph De-lorme, Madame Urbain Delorme and P. Ducherne were disallowed. Andrew Gibouche received scrip for \$160 in 1876 as head of a family.

No definite information can be given respecting Madame B. Gagnon or Charles Fruden unless names of patents are furnished.

PICTOU CATTLE DISEASE.

If investigation has checked, of its caused to disclose, the fact that the disease is caused by cattle eating that weed popularly known as 'Strutting Willie,' would the department favourably consider the proposal to render assistance to secure the eradication of the weed in the districts affected ?

Right Hon. Sir WILFRID LAURIER (for Minister of Agriculture) : 1. The department has, since October,

1903, been conducting an experiment station at Cloverville, county of Antigonish. with the object of ascertaining the cause of Pictou cattle disease.

2. Much valuable information has been

premature to make a definite statement, the results of the experiments so far indicate that the disease is not of a contagious nature, but that it is due to the ingestion, under certain conditions, of the weed known as Ragwort, or, locally 'Stinking Willie.'

3. The work at the station above referred to has been almost altogether in the direction of determining the cause of the disease with the hope of being able to devise some practical method of prevention. Incidental experimental work, however, would appear to indicate that benefit may result from the use of certain medicines in the early stages of the disease.

4. The department has not considered the matter.
