REPORTED REFUSAL OF SHIPPERS TO USE ST. LAWRENCE PORTS

Mr. J. R. Keays (Gaspé): Mr. Speaker, I have a question for the Minister of Labour. In view of the firm refusal of large maritime shippers to accept cargoes to or from Montreal, Quebec city and Trois-Rivières during the coming season, does the minister anticipate taking any action, other than asking for studies, to reassure the people of those cities that goods can be received or sent out from these ports?

Mr. Speaker, as I think the hon. member knows, negotiations between the shipping federation and the six or seven unions concerning the shipment of goods from the three St. Lawrence ports are still pending, with the assistance of the conciliation officer, since last January. A conciliation board has been requested. The names of the two nominees were received by me from the parties on February 23 and over the next week end the documents were prepared and signed appointing these two men and asking them to agree on a chairman.

In addition to this action, I might add that, pursuant to the assurance given to this house many months ago that on completion of the one inquiry into the activities of the ports in question there would be a second inquiry into the cause of work stoppages, I announced some days ago the appointment of Mr. Justice Arthur Smith of the Superior Court of Quebec to chair this second inquiry.
