#### OIL

EFFECT ON INDUSTRY OF NATIONAL ENERGY POLICY

Mr. G. H. Aiken (Parry Sound-Muskoka): Mr. Speaker, I have a question for the Prime Minister. Was the Acting Minister of Energy, Mines and Resources expressing government policy when he told the Canadian Petroleum Association in Calgary on Tuesday that there would be no special consideration for Canadian oil in a national energy policy?

Right Hon. P. E. Trudeau (Prime Minister): I will have to verify the statement, Mr. Speaker; I am not aware of it.

Mr. Aiken: A supplementary question, Mr. Speaker. I ask the minister if he would make available copies of his remarks in Calgary either to the house or individually to hon. members.

Mr. Orlikow: Or to the Prime Minister.

Mr. Trudeau: Send it by mail.

Mr. Hees: Not until after Easter, then.

Hon. Otto E. Lang (Acting Minister of Energy, Mines and Resources): Mr. Speaker, I would be glad to have the tape of my remarks transcribed and make a copy of the transcript available to the hon. member. I appreciate his interest. I would only like to say that the particular reference to the speech he has made, and several others which I have seen, would not be verified by the transcript.

MEDICARE-PARTICIPATION BY ONTARIO

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, I should like to direct a question to the Minister of National Health and Welfare. Is the minister in a position to make any statement concerning the discussions between himself and the minister of health of Ontario with respect to the prospect of that province coming into medicare?

Hon. John C. Munro (Minister of National Health and Welfare): I have nothing further to add, other than what I said about a week and a half ago subsequent to my last meeting with him.

Mr. Knowles (Winnipeg North Centre): I have a supplementary question. Can the minister indicate to the house how many other provinces, apart from those that are already in medicare, are discussing this possibility with the federal government?

Mr. Munro: My information is that three additional provinces will be coming in as of April 1 of this year, and that at least one or two others are considering coming in but have not definitely made up their minds.
