**YOUTH****OPPORTUNITIES FOR YOUTH PROGRAM—MODIFICATION OF ELIGIBILITY CRITERIA**

**Mr. Henry Latulippe (Compton):** Mr. Speaker, in view of the great number of protests from citizens who see that a large proportion of the funds allocated to the Opportunities for Youth program is simply being wasted, under Standing Order 26 I move, seconded by the hon. member for Rimouski (Mr. Allard):

That this House adjourn immediately in order to pass the necessary amendments to the eligibility requirements for the Opportunities for Youth program.

**Mr. Speaker:** The hon. member for Compton gave the chair the notice required by the provisions of Standing Order 26, which gave me the opportunity to give serious consideration to his suggestion.

The hon. member suggests to the House that an urgent debate be held to consider certain aspects of the Opportunities for Youth program.
