### INDUSTRIAL DEVELOPMENT BANK

REDUCTION OF FUNDS AVAILABLE TO BANK—POSSIBILITY OF REDUCTION IN LOANS TO SMALL BUSINESSES

Mr. Stan Darling (Parry Sound-Muskoka): Mr. Speaker, may I direct a question to the Minister of Finance? In view of the minister's budgetary statement that there is to be a reduction of \$135 million in funds available to reconstitute the Industrial Development Bank, and as IDB small business loans were reported to be down some 27 per cent in the six months ending in March, this year, will the minister indicate if his budgetary statement reflects a further cutback in IDB loans to small businesses, or was he just reflecting the reality, namely, that IDB assistance to small business has already fallen dramatically?

Hon. John N. Turner (Minister of Finance): Mr. Speaker, I will have a difficult time answering the hon. member's question in the brief time available. Briefly, the cutback reflects some restriction on expansion of the activities of that institution over the next fiscal year.

## CANADIAN BROADCASTING CORPORATION

AVAILABILITY OF CORPORATION'S EDUCATIONAL FILMS TO SCHOOLS—GOVERNMENT ACTION

Mr. Dan McKenzie (Winnipeg South Centre): Mr. Speaker, my question is for the Secretary of State. As during the past four years school boards, school trustee associations, school teacher organizations and universities all across Canada have been asking the CBC for educational films which can be shown in Canadian schools, and as all these organizations have received from the minister and the CBC is the biggest runaround I have witnesses in my life, will the minister organize an immediate meeting with these groups and work out a plan, so that our Canadian schools and universities can obtain CBC educational films on a loan basis?

Hon. James Hugh Faulkner (Secretary of State): Mr. Speaker, as the hon. member knows, this is a matter for the corporation. Despite his rather intemperate premise, I want to be as helpful as possible. I believe that a decision in principle has already been taken and that the next stage is to work out a distribution system. The whole thing ought to be in place by the fall.

Mr. McKenzie: A supplementary question, Mr. Speaker. I have submitted Bill C-291, which is on the order paper. It is intended to amend the Broadcasting Act and would permit CBC educational films to be used in Canadian schools. Will the minister use his influence and have this bill referred to the Standing Committee on Broadcasting, Films and Assistance to the Arts so that legal and technical problems may be dealt with?
