POINT OF ORDER

MR. STEVENS—HANSARD REPORT

Mr. Sinclair Stevens (York-Simcoe): Mr. Speaker, yesterday, as Your Honour recognized, the Minister of Finance (Mr. Chrétien) alleged I had "tried to mislead the House" with respect to a question I had put to him during the question period. Your Honour expressed the view that it would be better if the word "tried" were removed from the record since it conveyed the impression I had deliberately sought to mislead the House. Looking through today's *Hansard* I note the word is still in the record, and I feel I should seek clarification of the position. As I understood your intervention yesterday, you felt the word should be deleted. The Minister of Finance gave no indication he was opposed to such a course; we assumed he was acquiescing in it, and I should now like to know whether the word ought to be deleted from the official record.

Mr. Speaker: I would have to confirm this, but I do not believe the official record can, in fact, be physically altered. It has simply to make reference to the fact that it was understood later that the intent of the use of the word by the minister had been withdrawn. I think the word would have to remain in the original text. However, I will ascertain what the practice is. I understand the point raised by the hon. member and I will examine it and see whether the interpretation I have given is the correct one.
