That Bill C-72 be amended in Clause 32

- (a) by striking out line 23 at page 14 and substituting the following therefor:
- "(a) subject to subsection (1.1) and (1.2), prescribing the circumstances in"
- (b) by adding immediately after line 44 at page 14 the following:
- "(1.1) An area in which there is significant demand may be established if
- (a) both of the official languages are spoken as a mother tongue by persons residing in the area; and
- (b) the number of persons who are in the linguistic minority in the area in respect of an official language spoken as a mother tongue is at least fifteen per cent of the total number of persons residing in the area.
- (1.2) Notwithstanding subsection (1.1) where the number of persons in the linguistic minority in an area described in subsection (1) is less than the percentage required under subsection (1.1), the area may be established as a bilingual district if before the coming into force of this Act the services of departments and agencies of the Government of Canada were customarily made available to residents of the area in both official languages."
- (c) by striking out line 2 at page 15 and substituting the following therefor: paragraph (1)(b), the Governor in".
