from Chase, British Columbia, Kamloops, British Columbia and from a number of other western Canadian cities.

Their concern is having read the NAFTA, the North American free trade agreement, it would appear that fresh water was not made an exemption to the deal. They are asking the government to explicitly say that fresh water is exempt from NAFTA because they are concerned that this government is agreeing to sell water in terms of inter-basin transfers to the United States and Mexico.

As a comfort they are asking the government, for goodness sake, to exempt fresh water from this particular trade deal.

## BILL C-91

Ms. Dawn Black (New Westminster-Burnaby): Mr. Speaker, I am pleased to present a petition from hundreds of Canadians across the country who ask this government to end Bill C-91 which seeks to licence further no name generic drugs in Canada and will allow brand name drug companies to market their drugs without competition from generics for periods up to 20 years.

They say that the price of new and existing drugs already increased substantially to individuals, to provincial and private drug plans since 1987 when the Liberals brought in Bill C-22 which allowed up to a 10-year period of no generic competition.

Therefore, these petitioners call on Parliament not to proceed with Bill C-91 and to also repeal Bill C-22 so that Canadians will have the full benefit from lower priced generic drugs and so that provincial and private drug plans can serve Canadians without being forced to charge higher fees or provide less coverage.

## POVERTY

Mr. Lawrence MacAulay (Cardigan): Mr. Speaker, pursuant to Standing Order 36, I am pleased on behalf of a number of Canadians from Alberta, British Columbia, New Brunswick, the rest of Atlantic Canada and Quebec to draw the attention of the House to the fact that hundreds of thousands of Canadian senior citizens live below the poverty line and that over 80 per cent of single women over the age of 65 live in poverty. The petitioners call upon Parliament to urge the government to ensure that Canadian old age security pensions are sufficient to meet the basic needs of Canadian senior citizens.
