ACTS OF PARLIAMENT

EARLIER PUBLICATION AFTER SESSION

Hon. John J. Connolly: Honourable senators will recall that on March 10, in the course of his explanation of Bill S-2 respecting the Revised Statutes of Canada, honourable Senator Pouliot brought to our attention that public bills in the Province of Quebec are printed in the Official Gazette of Quebec within a few days of the conclusion of the session of the Quebec Legislature; and he suggested that some similar action should be taken in respect of statutes of the federal Parliament, by having them published in the Canada Gazette shortly after the adjournment of this session of Parliament.

I have informed the honourable senator, and I now inform the Senate, that arrangements have been made whereby acts of Parliament are published now in separate chapter form approximately five weeks after they receive the royal assent. These publications, as they become available, are listed on the daily check list of Government publications which all honourable senators receive.

As a result of the remarks made by the honourable Senator Pouliot, and in order better to serve the requirements of the judiciary, all judges will receive a list of the statutes as they receive royal assent and any judge may get copies from the Queen's Printer upon application.
