2. Since April 20, 1968, and the date the answer to this question is prepared were any services, work etc. performed for the Prime Minister at any government office occupied by him, his staff or the Privy Council by Mr. Kripacz and/or Francisco Limited and, if so, in each case, what is a full description of the services performed, work done and the cost?

3. What was the total cost of all such services, work etc?

Hon. Judd Buchanan (Minister of Public Works): (1) During the period April 1, 1971 through May 2, 1977 a total of \$21,969 was paid by the Department of Public Works to Mr. Francisco Kripacz and/or Francisco Limited for services performed at the Prime Minister's official residence, 24 Sussex Drive, or the summer residence at Harrington Lake.
