The Young Woman's Experiences in Truro, Where She Sojourned for a Few Days--Her Letter to the Mysterious Mr. Milton Somebody--Told Contradictory Stories.

Truro, N. S., April 15-(Special)-Anna Barrington, who attempted to commit micide in Charlottetown, acted in a mys terious manner in Truro a few weeks ago She arrived on the 22nd March by tra and was carried, while in a fit, to the Victoria Hotel. The doctor who was called in thought the girl was hysterical and stated that she required constant atten-tion. In three days she left for Pictou. Miss Barrington is a rather pretty girl, short of stature and about 17 years of age She said that her home was in California but that her parents had been dead three years, after which event she went to live with her uncle, Percy M. Barrington, 210 South Ash street, New York. She had been ill at Bellevue Hospital for five months. The uncle, who is rich, sent her to Prince Edward Island to recruit and when she returned was to be adopted by him. En route she was ill for ten days at the Fall River hospital and had several fits on the trip. She stopped at Ellerhouse, N. S., and a doctor from Windsor was called to attend her. While the girl was in Truro she told contradictory stories and the general opinion was that she had here extined from home by some one who been enticed from home by some one who has deserted her. She talked of a man named "Milton" who, she stated, at one time she had known for three years, an at another, since childhood, and said that he had met her at Yarmouth.

While ill here she had a letter left at an adjoining hotel where she said that a man would call for it. The letter is as follows:

"I am still in Truro, as you see, and knowing that you are either here now o it advisable to let you know where I may be found. I am at the Victoria Temper ance Hotel until Monday. If you received this, call. Now, Milton, be sure and come won't you? I want to see one familiar face and also am dying to hear the news Your name must be Mr. Milton Isenor Mine is Anna Barrington from New York going to Charlottetown, P. E. I. I live with my uncle in New York. Answer no questions from anyone before seeing me I am quite ill. Dr. Eaton says I may get up tomorrow. I am sending this to Mait-land House as I presume you will call there

Miss Barrington stated that on leaving ome she had \$150 but when here she had only \$11 and a trunk check Boston to Yarmouth, but had no baggage. 
