

10. Resolved, That a sum not exceeding One hundred and ninety-seven dollars and fifty cents be granted to Her Majesty, for Department of the Interior—Amount required to pay salary of T. W. Hodgins, from 1st July, 1896, to 31st December, 1896 (notwithstanding anything to the contrary in the Civil Service Act), for the year ending 30th June, 1897.

11. Resolved, That a sum not exceeding Sixty-seven dollars be granted to Her Majesty, for Post Office Department—Amount required to pay Mr. John Esdale, employed as a temporary employee in the Inside Service of the Post Office Department, from the 4th July, 1896, to the 19th September, 1896, inclusive, at \$1 a day—Sundays not included, (notwithstanding anything to the contrary in the Civil Service Act), for the year ending 30th June, 1897.

12. Resolved, That a sum not exceeding Nine hundred and eighty dollars be granted to Her Majesty for Legislation.—Senate—To pay the widow or family of the late Honourable Senator Kaulbach the balance of his sessional indemnity and mileage, for the year ending 30th June, 1897.

13. Resolved, That a sum not exceeding Two thousand one hundred and fifty dollars be granted to Her Majesty, to pay for leather trunks, ordered last Session (Senate), for the year ending 30th June, 1897.

14. Resolved, That a sum not exceeding Six hundred dollars be granted to Her Majesty, to pay two extra clerks for Session of 1896, at \$300, for the year ending 30th June, 1897.

15. Resolved, That a sum not exceeding Two thousand five hundred and four dollars be granted to Her Majesty, to pay to the widows or families of the undermentioned Members who died during the last Session of Parliament, the balance of their sessional indemnity and mileage:—Lt.-Col. G. Amyot, \$650.80; Lt.-Col. F. C. Denison, \$839; J. Bryson, \$1,014.20, for the year ending 30th June, 1897.

16. Resolved, That a sum not exceeding One thousand seven hundred and fifty-eight dollars be granted to Her Majesty, for General Statistics, for the year ending 30th June, 1897.

17. Resolved, That a sum not exceeding One thousand seven hundred dollars be granted to Her Majesty, for Manitoba Census, for the year ending 30th June, 1897.

18. Resolved, That a sum not exceeding Three thousand five hundred and eighty-nine dollars and sixteen cents be granted to Her Majesty, for Statistical Year-Book—Balance due on 1894, French edition, \$1,939.16; Statistical Year-Book—Balance due on 1895, English and French editions, \$1,650, for the year ending 30th June, 1897.

19. Resolved, That a sum not exceeding Thirty-seven thousand one hundred dollars and seventy-seven cents be granted to Her Majesty, for Quarantine—Cattle quarantine, \$12,000; General quarantine and public health, \$18,000; Cattle quarantine to cover under-estimate for 1895-96, including \$333.33 for Dr. McEachren, Chief Veterinary Inspector for the Dominion, being for increased services performed, commencing 1st March, 1896, arranged for by last Minister of Agriculture, in Report to Council, dated 9th May, 1896, \$6,500.77; Tracadie Lazaretto—Omitted in main estimates, \$600, for the year ending 30th June, 1897.

20. Resolved, That a sum not exceeding Six thousand dollars be granted to Her Majesty, for Arts, Agriculture and Statistics—Permanent buildings for Experimental Farm Exhibit at Three Rivers, \$5,000; Central Experimental Farm, Ottawa—For repairs and apparatus necessary for carrying on the temporary work of the laboratory, which was destroyed by fire, \$1,000, for the year ending 30th June, 1897.

21. Resolved, That a sum not exceeding Five hundred dollars be granted to Her Majesty, to pay further amount required for the Women's Protective Immigration Society, Montreal, for the year ending 30th June, 1897.

22. Resolved, That a sum not exceeding Two hundred and ten thousand five hundred and ninety-nine dollars and seventy cents be granted to Her Majesty, for Militia—Pay of Staff, Permanent Corps, and Active Militia, including allowances:—Sub-head A—Pay of a Deputy Assistant Adjutant General, at Head Quarters, Ottawa, for 1896-97, \$1,800; Salaries and Wages, Civil Employees in Military Districts—Pay for June,
