Mr. James A. McGrath (St. John's East): Mr. Speaker, the hon. member may have anticipated my question but perhaps I could ask a further supplementary. Would the minister be prepared to make a statement on motions in respect of this very important matter in order to put the minds of Canadians at ease?

**Mr. Basford:** Mr. Speaker, I think the last two answers I have given constitute a statement. I am not sure, until the matter of the litigation is cleared up, that there is anything more I can say that would be useful, except to reiterate that the commissioner is acting within the law as fast as he can in processing applications for compulsory licences which will be granted as fast as they can be. When they are granted, I think this will have a beneficial effect for drug purchasers.

Mr. David Orlikow (Winnipeg North): Mr. Speaker, I should like to ask the minister whether, in order to achieve the objective of lowering drug prices in Canada, he is considering the imposition of a tax or setting a maximum on the allowable deduction of expenses for drug advertising, sales promotion and detail men?

Mr. Basford: Not at the moment, Mr. Speaker.
