RESOURCE DEVELOPMENT PROGRAMS—STUDIES OF POSSIBLE ECOLOGY EFFECTS

Question No. 479-Mr. Anderson:

- 1. What steps does the government plan to take to give legal force to the recommendations of the Science Council of Canada that persons embarking on resource development should first research the possible damage to the ecology of the region in question?
- 2. Is the Department of Energy, Mines and Resources or any other department undertaking any study of the effect of the Bennett Dam on the ecology of the area near Fort Chipewyan, Alberta?
- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): I am informed by the Departments of Energy, Mines and Resources and Fisheries and Forestry as follows: 1. Resource development programs on all lands coming within federal government

jurisdiction are controlled by departments of this government and such programs will be studied to ensure at all times that possible ecology effects are known. The recently announced federal government guidelines for pipeline construction in the north is an example of government policy in this regard. Under the Fisheries Act potential developers may be required to submit plans and specifications of their proposed works, so that pollution control provisions can be checked and approved or rejected.

2. The governments of Canada and Alberta have agreed to establish a task force to be headed by a Director nominated by the Department of Energy, Mines and Resources, to gather all of the information required to make firm recommendations to both governments on the action necessary to assure that the needs of the Peace-Athabasca Delta region are met by the spring of 1972. It is assumed that the region referred to is the area near Fort Chipewyan, Alberta. The information to be compiled by the task force will include study of the effect of the W.A.C. Bennett Dam on the ecology of the Peace-Athabasca Delta region. The Department of Fisheries and Forestry is setting up a task force to gather relevant data on the Lake Athabasca problem, and to determine appropriate remedial action.

NATIONAL HEALTH AND WELFARE—LIST OF DRUG QUALITY AND EQUIVALENCY

Question No. 486-Mrs. MacInnis:

On what date will the government make public its list of drug quality and equivalency as recommended by the Special Committee on Drug Costs and Prices in 1967 along the lines already undertaken by the Ontario Government?

Hon. John C. Munro (Minister of National Health and Welfare): The Department of National Health and Welfare will publish the first list of drug products meeting specified criteria of quality, early in the year 1971. This material will appear in the Drug Information Bulletin " $R_{\rm x}$ ", a monthly publication of the Food and Drug Directorate which is sent to all physicians, dentists, veterinarians, and retail and hospital pharmacies in Canada.
