#### **BUSINESS OF SUPPLY**

ALLOTTED DAY S.O. 58—ALLEGED FAILURE OF GOVERNMENT TO DEVELOP FAIR AND JUST POLICIES RESPECTING OIL AND GAS RESOURCES

### Mr. John C. Crosbie (St. John's West) moved:

That this House regrets the failure of the government to develop and apply policies in the fields of the oil and gas non-renewable energy resources that are fair or just or adequate for the people or the provinces of Canada today or for the future.

He said: Mr. Speaker, it is with considerable regret that I have to be critical of the government again today, having had to be critical of it last night; but one has to be truthful when speaking in this chamber and the subject matter of this motion will fit in with what I was saying last night. Hon. gentlemen opposite came into office on the basis of co-operative federalism, but they have now degenerated to strong-arm federalism or, as I said last night, to forced federalism or goon-squad federalism—anything but co-operative federalism. They came into office on the basis of participatory democracy, which has also vanished into limbo because the only democracy now is conference-hall autocracy.

The same thing is true in the energy field. What is the good of hon. gentlemen opposite publishing the study called "An Energy Strategy for Canada" when they ignore the recommendations of their own study or twist it in their administration so that it is unfair and unjust, as this motion says. The motion says that their policies are neither fair, just nor adequate for the people or the provinces of Canada.

I want to touch on three subjects in the short time allotted to me which I believe is 30 minutes. First, I want to touch on the new conservation policy, announced by the minister at the beginning of February, for Nova Scotia and Prince Edward Island dealing allegedly with conservation of energy in those two provinces and confining it to those two provinces for spurious reasons.
