INSURANCE

LIABILITY PREMIUM INCREASES—REQUEST FOR COMBINES INVESTIGATION

Mr. Alfonso Gagliano (Saint-Léonard-Anjou): Mr. Speaker, my question is directed to the Minister of State for Finance and concerns the insurance crisis. So that the Minister can understand the importance of this crisis, I will give an example of the terrible tragedy. The General Hospital of Toronto had to pay an increase of some 700 per cent this year over last year for liability insurance. Does the Minister believe that the insurance industry is doing something wrong? Will she support today the demand for an investigation made by 10 Members of Parliament asking Director O'Farrel to investigate the insurance crisis?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, I think I should explain to the Hon. Member that several times in the House I have expressed my concern for this issue. I have tried to explain to the House the importance between our area of responsibility and that of the provinces. The provinces have taken some appropriate action to deal with what is indeed a very real problem and one about which we care a great deal. Our policy concerns have to do with solvency and the capital base. Those are the kinds of issues which we will be bringing to the House in the process of our entire examination of the financial services industry.

Yes, I do care a great deal, and we are in touch with the industry on this basis. However, it is important not to leap into someone else's area of responsibility every time there is a problem.
